Subsidy/Tuition Assistance Explanation

1. **St James Parish/School Subsidy** is given to qualifying parishioners of St. James Parish. In order to qualify for the in parish tuition rate, a family must be registered at St. James Parish, attend church in the parish and give identifiable financial support to the parish.
2. An **Out-of-Parish Subsidy** is for families registered at another parish without a school. The pastor needs to sign the out-of-parish for in order for the family to receive the in parish tuition rate.
3. Tuition Assistance is processed through “**FACTS**”, an archdiocesan tuition assistance program that rates financial need. St. James also has monies available for Tuition Assistance from our Endowment Fund.
